This order is published to confirm verbal orders issued during the period Aug 3 - 8 (incl) 1943.

MAPS: Cicsopac Photomap, 1/20,000.

- 1. a. See current summaries.
 - b. (1) The XIV Corps with the 25th Div (-) in assault, will continue the attack north from BIBILO HILL in order to destroy all enemy resistence on the NEW GEORGIA mainland.
 - The 43d Div (-) will establish a beach head defense of the MUNDA area south of the 40.0 grid line.
 - The 37th Div (-) will protect the supply route of, and be prepared to assist the 25th Div (-).
- The 25th Div (-) supported by 136th FA Bn, 140th FA Bn, one (1) plt tanks of 11th Mar Def Bn, and Det South Pacific Scouts will advance to the north from the vicinity of BIBILO HILL, secure the MUNDA-BAIROKO ROAD, locate and destroy enemy resistance, and make junction with the LIVERSEDGE force. Boundaries and formation: See Opns Overlay.
- The 27th Inf will attack north up the ZIETA-BAIROKO TRAILS and destroy all resistance between PIRU PLANTATION and SUNDAY INLET. Not to exceed one (1) Bn will advance up the BAIROKO TRAIL to MT. BAO. From that location it will turn west along the trail and foin the remainder of the Regt at MT. TIROKAMBIA.
 - The 161st Inf will advance north up the BAIROKO TRAIL in rear of one (1) Bm, 27th Inf. When it arrives at MT. BAO it will continue the advance and will in conjunction with the LIVERSEDGE force destroy all enemy resistance between SUNDAY INLET and ENOGAI INLET.
 - (1) The Div Arty will support the defense of the Div from present locations and will be prepared to echelon forward in order to extend this support to the north and west shore.
 - 89th FA Bn in direct support of 27th Inf.
 - 140th FA Bn in direct support of 161st Inf. 136th FA Bn in general support.
 - (o)
 - The 65th Engr Bn will furnish Engr support to front line Regts and assist the Arty in its displacements. Every effort will be made to construct and maintain roads in rear of the columns advancing on the ZIETA and BAIROKO TRAILS.
 - x. (1) Units will habitually establish an all around defense during the hours of darkness.
 - There will be no movements of troops or supplies during the hours of darkness.

NOTE: This order is published to confirm verbal orders issued by the Commanding Officer, 27th Infantry, during the period Aug 3 - 8 (incl) 1943.

- a. The enemy is believed to be evacuating the BIBILO HILL MUNDA area to the NW toward BAIROKO and the PIRU PLANTATION - SUNDAY INLET Areas.
 - b. The XIV Corps, 25th Division in assault, will continue the attack to the N and destroy all enemy resistance on the New Georgia mainland.
- 2. The 27th Inf supported by the 39th FA Bn will attack N up the ZIETA and BATROKO Trails and destroy all enemy resistance between PIRU PLANTATION and SUNDAY INLET. The 148th Inf will protect the supply route of and be prepared to assist the 27th Inf.
- 3. a. The 1st Bn with the AT Co atchd will advance N along the BAIROKO TRAIL to MT. BAO. The Bn will seize the RJ at MT. BAO and proceed W. The AT Co will hold the RJ until relvd by the l61st Inf. The Bn will rejoin the regt at MT. TIROKIAMBA.
 - b. The 3rd Bn 27th Inf will advance generally NW along the ZIETA TRAIL. The Bn will destroy any enemy resistance along the trail.
 - c. The 2nd Bn 27th Inf will initially move into regil reserve in the vicinity of former 148th Inf CP W of RJW. The Bn will follow and maintain contact with the rear of the 3rd Bn 27th Inf.
 - d. The 89th FA Bn will be prepared to furnish artillery support to the ZIETA column.
 - e. The 140th FA Bn will be prepared to furnish artillery support to the BAIROKO column until the 1st Bn 27th Inf moves W from MT. BAO.
 - f. Co. "B" 65 Engr will furnish Engr support to the leading Bns.
 Every effort will be made to push jeep roads to the forward
 supply dumps of the leading Bns.
 - g. Co "C" 25th Med Bn will maintain collecting station in vicinity of RJW.
 - (1) Units will habitually establish all-around-defense during the hours of darkness.
 - (2) There will be no movement of troops or supplies during the hours of darkness.
- 4. a. Ration and Ammunition DP will be established approx 300 yds S of RJW. Water DP will be located at LAMBETI PLANTATION until more advanced DP is established.

H E A D Q U A R T E R S TWENTY-SEVENTH INFANTRY Forward Echelon 1200, 19 August 1943

NOTE: This operations memorandum confirms the oral orders of the Commanding Officer, Twenty-Seventh Infantry, issued 17 August 1943.

- 1. The 2d Bn 27th Inf will move from its present location early on 18 August to make a vigorous reconnaissance with a view to occupying PIRU PLANTATION at the earliest practicable date and denying the use of DIAMOND NARROWS to the enemy. Direction of March: N to a point 900 yds N of the present location of Co $^{\rm nFn}$ 27th Inf, thence NW on Mag Az 330°, thence following solid ground to the N end of PIRU PLANTATION.
- 2. The 3d Bn 27th Inf will leave its present location on August 19th. It will follow the route of the 2d Bn 27th Inf, maintain contact with and forward supplies to the 2d Bn.
- 3. The 3d Bn 148th Inf (atchd) will leave its present location on August 20th following the route of the 3d Bn 27th Inf. It will maintain contact with the 3d Bn 27th Inf and forward supplies for the two leading battalions to the 3d Bn 27th Inf.
- 4. Base of supply until further orders in the vicinity of ZIETA VILLACE. Thereafter, upon my orders , vicinity of MT. TIROKIAMBA.
 - 5. C. R. 27th Inf: Present location until further orders.

HEADQUARTERS TWENTY-SEVENTH INFANTRY Forward Echelon 21 August 1943

NOTE: This operations memorandum confirms the oral orders of the Commanding Officer, Twenty Seventh Infantry, issued 21 August 1943.

MAPS: Cicsopac Photomap, 1/20000.

- 1. The 2d Bn 27th Inf will move approximately 1800 yds S of its present position to the junction of the Cutter Point Trail and the trail leading N from Zieta. From this point the Bn will proceed along the Cutter Point Trail E of the PIRU PLANTATION. This move will be made early 22 August, and the Bn will bivouac for the night on the solid ground. At dawn 23 August the Bn will assault PIRU PLANTATION.
- 2. The 3d Bn will move from its present position 23 August. The Bn will proceed N to the Cutter Point Trail. From this point the Bn will generally follow the rout of the 2d Bn 27th Inf and bivouac the night of August 23 in the area previously occupied by the 2d Bn 27th Inf. The Bn will enter PIRU PLANTATION the morning of 24 August and be prepared to support the attack of the 3d Bn 27th Inf.
 - 3. The 3d Bn 148th Inf will remain in its present location.
- 4. A patrol consisting of the Regtl Recn O, Regtl Wire Sect, and a cutting party from the 3rd En will preceed the 2d En and cut and mark the Cutter Point Trail.
 - 5. Forward C. P. 27th Inf: C. P. 3d Bn 27th Inf. Rear C. P. 27th Inf: Present location until further orders.

COMBAT REPORT 27TH INFANTRY

CAMPAIGN AGAINST THE JAPANESE, NEW GEORGIA, B.S.I.

PERIOD: 31 July to 10 September 1943.

ENEMY UNITS ENCOUNTERED:

229th and 230th Infantry (38th Division). Both of these Regiments were stationed at New Georgia at the time of the original American landing.

b. 13th and 23rd Infantry Regiments (6th Division). Neither of these units were stationed at New Georgia at the time of original American landing, and only small detachments were sent to reinfonce the other enemy troops stationed on that Island after the fighting had started. Captured documents indicated that units of the 13th Infantry came from Kolombangara and units of the 23rd Infantry from Santa Ysabel, 3 August 10.2 1943.

C.G. 43rd Div.

Attack jumped off as scheduled. No enemy resistance yet encountered.

C.O. 27th Infantry

0730

C.G. 43rd Div.

Forward elements had advanced 800 yards at 0830 and met no resistance. Advance is continuing.

C.O. 27th Infantry

0850

G-3, 43rd Div.

Reached point 200 yards east 61 Grid Line at 1030. Passed extensive Jap bivouse of estimated 200 Japs. We continue to advance. No enemy contacted as yet. We hear extensive rifle and machine gun fire estimated 800 yards east.

1030

C.O. 172nd Inf

Have advanced 400 yards east of 61 Grid as of 1110 and am continuing advance. Will join with you today.

C.O. 27th Infantry

1124

C.O. 3rd Bn

Place a trail block of 1 rifle company across Jap trail running north - south near the 61 Grid. They will face north along the shore and cover the north end of the trail with LMG's. Their mission will be to block the trail and secure the rear of the 2nd Battalion.

C.G. 43rd Div.

Our advance units have met slight enemy resistance strength undetermined in vicinity of 62 Grid. Assault companies are continuing to advance. Urgently request information of location of 172nd forward units.

Our assault companies crossed 62 Grid at 1350 and are continuing to advance. We are receiving some enemy rifle fire probably from rear guard units. We have suffered some casualties. Have passed through another Jap bivouac area larger than the first. Abandoned ammunition and other supplies indicate enemy withdrew hastily.

Our assault companies crossed 62 Grid at 1350 and are continuing to advance in front of enemy rifle fire. Request accurate report of dispositions of your assault units and enemy situation on your front.

You are directed to move out immediately on an azimuth of 30 degrees. This will bring you in rear of our forward units. Be careful not to fire on our troops.

We are north of river, azimuth of 30 degrees will not take us in rear of our forces will have to move on azimuth of 190 degrees then cross river and move up to old able co.

C.G. 43rd Div.

Hartford patrols - Grant Island - Negative. Patrol from B Company to C Company negative. Patrol from C Company to rear elements 27th negative. OF 15 on Islands four, seven and ten. 27th Infantry patrol from stepping stene island to north of Sagekarasa went through old Jap bivouac area and established outpost on north coast. No Jap contact. No more enemy artillery fire since first incident. Enemy dispositions unknown.

Enemy approximately six four point zero dash six nine point zero. Well organized apparently all around defense. Plan as sent to G-3, 43rd Division. Nearly all occupied by friendly.

G-3, 43rd Div. Important send one company 1st Battalion 27th with I Company one seven two to west end of that peninsula to block Jap supplies. 1st Battalion 27th less company advance as planned.

2nd Battalion 27th reports Jap attack penetrated right center of line. Quick counter attack has driven Japs out and now line is solid. 3rd Battalion 27th block secure. Claim killed 25 Japs on west side.

Japs have been aggressive all day both at Sagekarasa and at 2nd Battalion 27th. Our lines holding. Believe Jap casualties pretty heavy.

G-3, 43rd Div. Plan today 1st Battalion 27th on right flank. 2nd Battalion extend around to coast and encircle enemy. Tanks to assembly

A reconnaissance patrol left 3rd Battalion CP at 0700. Proceeded 400 yards east along a Jap trail which followed the high ground in center of the island. They went through a Jap bivouac area consisting of about 12 shacks. In two of the shads found a total of 4 dozen life preservers which were dry. Bivouac had nt been occupied for some time. Patrol continued another 100 yards to east and returned at 0830.

Bomber landing procedure observed at Vila:

- White light flashed at 63.0 72.7, approx. coord., vicinity Vila Point.
- 2. Seaplane took off and circled.

3. A bomber circled Vila.

4. MG tracers came from 66.1 - 74.2.

- 5. Bomber then circled between Devil's Island and Vila, and dropped a white flare which turned green before hitting water. Then went over field and dropped another flare of same type.
- Bomber then circled over MG tracer position and fired a burst of tracers.
- 7. Then two or three other bombers joined the first one and landed
- Meanwhile, the seaplane flew over Piru, drawing AA fire.

9. The bombers took off from Vila about midnight.

COMBAT REPORT 27TH INFANTRY

CAMPAIGN AGAINST THE JAPANESE, ARUNDEL, BRITISH SOLOMON ISLANDS

AND OCCUPATION OF KOLOMBANGARA ISLAND

PERIOD: 10 September to 12 October 1943.

ENEMY UNITS ENCOUNTERED:

13th Infantry (6th Division): Information obtained from captured documents and prisoners indicated that practically the entire 13th Infantry (known as the "Pride of South Japan") with the 3rd Independent Rapid Fire Company, 1st, 2nd, and 3rd Independent Machine Gun Companies, and supporting artillery from Kolombangara participated in the fight on North Arundel, a total of at least 1000 men. The 13th Infantry had, at the time, only recently arrived from Bougainville to Kolombangara, thence to Arundel.

ENEMY KILLED:

a. Arundel: 600 by Infantry and Artillery action. It is impossible to estimate the number killed by artillery and mortar. In the devastated area of North Arundel and Sagekarasa numerous shallow graves were found all along the trails and at one point along the coast 25 bodies were floating in Blackett

b. Kolombangara: 3 killed by Infantry. No estimate of enemy killed by artillery.
